 - Waste minimisation and a commitment to restrict waste to landfill;
 - Management of waste disposal including re-use and recycling where appropriate;
 - o Communications, consultation, health surveillance and advisory facilities as required.
- Develop and review clear health and safety performance indicators, which drive continuous improvement including:
 - Operation of a robust H&S management system fully accredited to ISO 45001:2018;
 - o Accident and incident performance, including near miss recording;
 - Accident & incident investigation, and implementation of suitable corrective and preventative actions;
 - Annual safety, health, environmental and quality objectives;
 - o Training achievement and identifying requirements through gap analysis and continual development;
 - o Customer satisfaction.
